Again, there's a lot of different issues. We have to work through and as soon as we get a better understanding of the specific date of opening and the specific. You know the specifics and how that's going to work. We will certainly communicate that with you. It's there's a lot of similarities with what we originally put out in our reopening plan, but based on some changes we do have some modifications but again to tell you all the details right now, they're potentially will change. So that's the update we're working on it. We'll have it to you soon as possible. And the remote experience is going pretty well. I will mention that we have had major issues with connectivity. But again that your school team is always looking for Creative Solutions and those connectivity issues have dwindled. They're they're very small not as frequent. It's much better. So we're we're in pretty good shape. So Just to give you an update.
