Department of Health on July 31st those plans have to account for scenario where we're fully reopened. Where we have a hybrid reopening meaning some students are being taught online While others are in person in school and scenario three, which is an online program. there The state document was 145 pages with literally hundreds of requirements along with the Department of Health, which also has a great number of requirements that we have to have in plant and place for the reopening plans. The governor is going to make a decision on reopening sometime the first week of August and that decision will then tell us what to expect he has shared the metrics that he's using for making his decisions. And that is if the infection rate is 5% or less or 14-day period is decision maybe for there to be in person education if the infection rate is 9% or higher he is going to keep schools closed. You also indicated that the decision he makes the first week in August and change before school begins depending on the course of the pandemic and the phase that various regions are in at the time that schools to open. We have conducted surveys of our staff. And of our parents our staff survey was completed sometime last week and I've been working on that with our staff. Our parent survey was completed this past Sunday and there are a lot of responses to work through. So we're working on those as we speak and I'm hopeful to have that completed in the near future. I will present the a summary of those results to the board at a future meeting once we have those and we're using the information in those servings to help inform our plans for the three scenarios. And we're also conducting our hiring for several positions that we still have to fill in. And that's pretty much it reopening has taken up the line share of everyone's time for lots of hours and it's a pretty huge undertaking and I'm very thankful for the support. I have from staff and board and and everyone involved in this it's a it's a huge Bank of undertaking and And it's it's the one that I wish we didn't have to plan for. So that's the report that was if you have any guestions.
